Land adj. to The Stables, Station Road

Councillors objected to this application for the following reasons;

- The proposal is for a house presenting an overbearing mass in the context of this site. The principle behind the granting of an Outline Permission must be that the Reserved Matters can constrain an inappropriate end result. The officer, in granting Outline Permission in this case, made specific reference to the site being able to accommodate a dwelling of similar size and layout to those neighbouring the site with acceptable front and rear amenity space. Clearly this proposal runs counter to that expectation.
- The amenity of neighbouring properties at Fox View to the north and on Crown Mill to the east will suffer considerable negative impact both by virtue of overlooking and should be able to rely upon the Planning Practice Guidance stricture that good design should work well for everyone. Design such as this which begins with maximising internal space can produce a result which, as in this case, pays no regard to the neighbouring built environment or to the amenity which can rightly be expected within that environment.

Local Plan policies urge a 'positive contribution' to be expected from development proposals. In this case the result would be a crass imposition on the immediate neighbourhood. It is inappropriate and should not be permitted.
